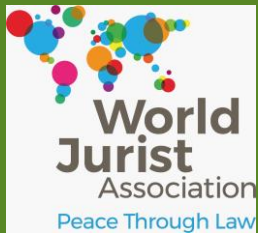
# Overview

It advances the spotlight on Nature-Justice-Peace issues which will be developed during the 2023 World Law Congress (NY, 20 and 21 July), organized by the WJA. These Madrid 5<sup>th</sup> May's *Dialogues on Nature, Justice, and Peace* dive into the intimate interrelation between environmental issues, on the one hand, and justice and peace, basic and interdependent concepts-realities, on the other hand. The first panel focuses on the judicial field while the second does so in the compound realm of security, peace and conflicts. In both cases, leading experts make reflections based on their well-recognized professional expertise in the field. Their assessment will contribute to show implications of such interrelations, as well as possible avenues for the holistic treatment that is needed in all this matter.
