Overview and Organizers



International Council of Environmental Law



This International Symposium is jointly organized by the *International Council of Environmental Law* (ICEL), the *Universidad Carlos III de Madrid* (UC3M) and the *University of Vigo* (UVigo). This event convenes policy makers, academics, legal practitioners and civil society leaders in the framework of the *PaxNatura* Research Project, funded by the Spanish Ministry of Science and Innovation (Ref.: PID2022-1424842022).

The *PaxNatura* Project (*Nature, Conflict and Cooperation: The Transformative Power of Law over Actors, Spaces, Resources, Behaviors and Harm*) is composed of two parts: *Peace with Nature and Making Nature a Key for Peace* (P1) and *Making Justice to Make Peace with Nature: The Judicialization and other Forms of Jurisdictional and Institutional Protection of Nature* (P2). On the one hand, P1 is of a general and comprehensive character, constituting a capable framework to cover practically any kind of legal initiative for protection in nature-related matters, following an approach that is primarily top-down; while on the other hand, P2 focuses on more specific aspects, although it is also broad in scope, following a prevailing bottom-up approach. Along with these features, P1 is characterized by focusing mainly on peace, while the second does so on justice. The interdependence between both is evident, since there can be no peace without justice and no justice without peace. The simultaneous consideration of both centers of gravity, peace, and justice, for the protection of nature and the achievement of sustainable development is crucial. The valuable alliance with ICEL as well as with other relevant entities has been envisaged to better fulfill such aims.
